### ANNOUNCEMENT

FOR : HEADS OF CONSTITUTIONAL BODIES, DEPARTMENTS, BUREAUS AND AGENCIES OF THE NATIONAL GOVERNMENT, LOCAL GOVERNMENT UNITS, GOVERNMENT-OWNED OR CONTROLLED CORPORATIONS WITH ORIGINAL CHARTER, AND STATE UNIVERSITIES AND COLLEGES IN REGION V

SUBJECT : **Painting Contest**

In celebration of the 124<sup>th</sup> Philippine Civil Service Anniversary with the theme, “Transforming Public Service in the Next Decade: Honing Agile and Future-Ready-Servant Heroes,” the Civil Service Commission Regional Office No. V will conduct its second Painting Contest. This activity will showcase government officials and employees’ creativity through painting. The painting should highlight the theme “*Canvas of compassion: Painting the Heart of Public Service in the New Normal.*”

### ELIGIBILITY AND ENTRY REQUIREMENTS

The contest is open to all government agencies in the Bicol region. One (1) or more entries may be submitted by participating agencies provided that paintings are made solely by their bonafide official or employee (*only 1 entry per employee will be accepted*) with permanent, temporary, coterminous, contractual, substitute, provisional and/or casual status.

Participating agency/ies shall submit their intent to join using the attached format to the CSC Regional and/or Field Offices **on or before 30 April 2024**.

The painting entry/ies must conform with the following specifications/guidelines:

Size/Orientation – 20”x24” in horizontal/landscape orientation (excluding the frame)

Medium – The acceptable media are oil on canvas, acrylic on canvas or watercolor on canvas only.

Entry for submission should be in museum wrap or box type.

Entries must be dated not earlier than 2024 and must be the original works of participating agencies' artists. Entries must not have been exhibited before, and awarded a prize in previous competitions.

Entries must be signed by the artist. It must also be properly labeled using a card tag or card caption to be placed at the back of the painting. The card tag must contain the following information:

All participating agencies must be responsible for bringing and transporting their entries to CSC Regional Office **on or before 19 August 2024**.

Entries submitted after the stated date and those non-compliant with the requirements shall be automatically disqualified.

*All entries submitted shall automatically become the CSC RO V's property.*

### JUDGING

The CSC RO V shall facilitate and select the Board of Judges.

The decision of the Board of Judges shall be final.

#### **Criteria for Judging**

30% relevance – clear interpretation or expression of the theme

30% creativity – creativeness or refreshing perspective in depicting/portraying the theme

30% originality – undeniably novel and unique. It must be an original concept and not a copy of anyone else's copyrighted material.

10% people's choice – highest number of likes/hearts in the CSC Facebook page (official entries shall be announced online thru the CSC RO V FB page).

**AWARDS/PRIZES**

The winners will receive a certificate of commendation and the following cash prize:

Grand Winner	P10,000.00 plus one (1) free leadership training (redeemable within 1 year from issuance of the voucher)
1 <sup>st</sup> Place	P7,000.00 plus one (1) free leadership training (redeemable within 1 year from issuance of the voucher)
2 <sup>nd</sup> Place	P5,000.00 plus one (1) free leadership training (redeemable within 1 year from issuance of the voucher)

All non-winners will be given 1 free technical training which may be redeemed within 1 year from issuance of the voucher.
