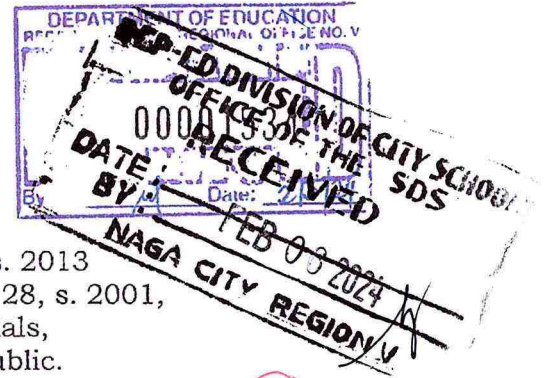

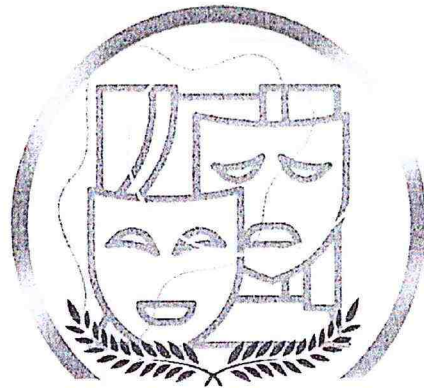

RATIONALE

It is high time to enhance the young people capabilities to mount/showcase a performance, playwrighting/creative writing, and technical creativity in reviving some Filipino moral values that focus on the journey through our life in the Philippine context which envisions to give relevance to the contemporary lives of the Filipino people with emphasis on our life and live's celebration and youthfulness amidst the social, political, and economic challenges. Thus making the people aware of the value of theater work in the immense spectrum of development so as to inculcate in the mind and soul of our people a sense of patronage and pride in our own cultural heritage within the context of developing our own Filipino identity and nationhood.

OBJECTIVES OF THE FESTIVAL

To promote, revive, re-invent, and strengthen our culture as Filipinos and encourage the young generation to practice our native dances, music, theater and arts to re-established our own identity;

To enhance the artistic talents and aesthetic values of our learners;

To deepen learners' knowledge of Philippine culture and arts as well as their communication skills.

To create new performances expressive of local stories, concerns, issues and forms.

To exhibit sense of camaraderie and social commitment thru theater performances

FESTIVAL MECHANICS

1. The festival competition is open all recognized school based theater groups in the country.
2. Each participating production shall be composed of a collaboration of at least two [2] school based groups, regardless of whether the group are from public or from private schools or a more "laudable" mixture of both .
3. Each production shall a maximum length of twenty five minutes including ingress and egress.
4. The general theme of the festival is **LAYAG KABATAANG PILIPINO, MAKILAHOK SA MALIKHAING SIMBAHAYANAN** which encourages maximum participation and involvement of many groups from schools, church, and community.
5. The play shall manifest and/or explore local forms, materials, and stories from schools and communities which 'acknowledges the arts as rooted in the local milieu and celebrates its nature as an empowering and transformative medium of personal and social change.'
6. The production must not have won any prize/award/citation in any local, regional, or national.
7. The play may use any artistic form like musical theater, dance theater, straight realistic theater, experimental theater or any combination of form or styles. If the play will have lines and/or narration, those shall be in Filipino.
8. Each participating collaborating group shall submit duly accomplished registration form and the endorsement /certification that the groups are recognized by their respective schools, and/or community. Each participating collaborative theater groups shall submit certificate of recognition from their respective schools.

9. Interested collaborative groups must contact DTL National Secretariat to express their intention and to reserve for their entry slot on or before February 28, 2024 11:59pm. Only ten [10] participating collaborative groups to reserve slots on a first come first serve basis.

10. Required documents are

- A] DULY ACCOMPLISHED REGISTRATION FORM;
- B] CERTIFICATION LETTER FROM RESPECTIVE SCHOOL/COMMUNITY SIGNED BY THE HEAD ATTESTING THAT THE GROUP IS RECOGNIZED BY THE ACADEMIC INSTITUTION;
- C] PROFILE OF THE GROUPS INCLUDING PAST PRODUCTIONS;
- D] SYNOPSIS/STORYLINE/ AND SCENE BY SCENE TREATMENT/BREAKDOWN;
- E] PRODUCTION AND ARTISTIC STAFF AND CASTING;
- F] TWO [2] PRODUCTION PICTURES.

11. The competition is open to all recognized school based performing arts groups in the Philippines. Paces individual members are encouraged to join the competition. Trainer/coach and other artistic/creative staff of the participating groups must be a paces member and/or encouraged to join the society.

12. All expenses in joining the competition shall be shouldered by the participating groups.

13. Solidarity/registration of one thousand pesos only will charged to each participating group in every event to defray the administrative and other related cost of the program which may be sourced from the school mooe and/or local school fund subject to usual accounting procedures.

14. Executive organizing committee reserves the right to amend these guidelines or refuse any entry on any ground with proper advice to the party 's concerned.

15. Personal photography and video taping will be strictly prohibited during the competition proper. Official photographers and videographers will be provided by the organizers for documentation purposes.

16. Decision of the Board of Adjudicators is final and irrevocable.
