Greetings of peace and good health!

One of the primary objectives of Philippine Mathematics for Eligibility operating under Phil-MATH-4E is to help Filipino students and graduates acquire the necessary knowledge and skills for Civil Service Examination and Board Examinations through the conduct of academic competitions. It is miserable that among the 350 000 plus CSE test takers each year, only less than 18% usually pass. Being a lecturer, some of the observed reasons may include the following:

- 1) They do not have a good foundation on the basic or fundamental knowledge and skills especially in Mathematics and English at a high school level.
- 2) They just take the exam without reviewing very well as they just want to take the exam by chance to pass it.

It is then necessary that as early as the students are in high school, we provide them an avenue for them to at least test their knowledge and skills related to Civil Service Examination with the following benefits:

- 1. The students will be challenged to strive towards academic excellence with a goal of passing a national exam.
- 2. The learning experiences they will be encountering during exams may help them pass soon the Sub-professional and Professional Civil Service Exam without incurring one or multiple failed exam records at the Civil Service Commission.
- 3. They may be encouraged to take the civil service exam as early as possible.
- 4. The teachers will be aware of the coverage of the exam for possible lesson integration.
