

- Pursuant to DepEd Memorandum DM-CT-2024-040, re: Administration of the National Learning Camp Assessment (NLCA) for Grades 7 to 10 public school learners, this Office through the Bureau of Education Assessment (BEA) will conduct the said assessment through an online computer-based modality.
- The test shall be administered at the identified testing centers of SDO: Camarines Sur National High School (Main and Liboton), Cararayan National High School, Carolina National High School, Leon Q. Mercado High School, Naga City Science High School, Naga City School of Arts and Trades, and Tinago National High School.
- 3. The National Learning Camp Assessment shall cover learning areas in English, Science and Mathematics, wherein test items measure varying levels of skills and competencies in a multiple-choice test format using the English language.
- 4. The NLCA shall be administered on the following dates:

9 and 10		April 15-May 17, 2024


In connection with this, the school's division office shall conduct an orientation on March 7, 2024 at SDO Conference Hall.
