Further, all Planning Officers shall communicate the status to the concerned schools to collect the reason/s of the decline of the enrolment and it will be reported and/ submitted by Chief of the SGOD during the conduct of the CY 2023 Seventh Regular Regional Management Committee Meeting on December 18, 2023 at a venue to be announced later.
