**(GUIDELINES ON THE REGISTRATION AND EVALUATION OF DOCUMENTARY REQUIREMENTS FOR THE 2024 SPECIAL PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT))**

1. Under Department Memorandum No. 034, s. 2024 dated July 15, 2024, the Department of Education through the Bureau of Education Assessment, announces the administration of the 2024 Special PEPT on **August 4, 2024**, at **Triangulo Elementary School**.
2. The PEPT is a nationally administered assessment for learners in special circumstances. The result of the assessment will allow learners to access or resume schooling and/ or obtain certification of completion by grade level in the DepEd formal system.
3. The placement of the PEPT qualifiers for this test administration shall take effect in the current school year when the test is administered according to Section 6 (Grade Level Placement Assessment) 2.b. of DepEd Order No. 55, s. 2016 titled Policy Guidelines on the National Assessment of Students Learning for the K to 12 Basic Education Program.
4. The examinees are expected to be at the venue at 6:00 A.M. She/He must bring the registration form signed by the authorized evaluator, test item placement, two pencils (No. 2), an eraser, and a sharpener.

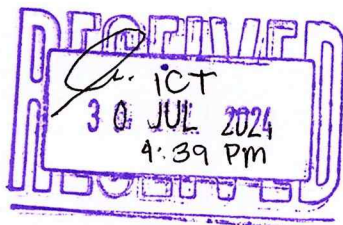
